Established in 1930, the MCVFA is a non-profit organization working to support the interests of volunteer firefighters in Monroe County. Though the use of meetings, training events, recreational activities and participation in various legislative activities, we help to advance the safety, interests and concerns of our members.

As you are well aware, 2020 has been a difficult year for conducting any Association meetings and activities. It is anticipated that we will return to full strength once COVID is over.

Acting as a public face for volunteer firefighters, the MCVFA sponsors the the Annual Fire/Burn Prevention Essay contest for school children and also participates in the annual, Educational Health Fair, held at the RIT Convention Center in October. This year MCVFA will be sponsoring a 4 hour training seminar, about Public Information Officers and media relations (the seminar cancelled from 2020). MCVFA members will be able to attend at a reduced price. We are also working with the Monroe County Fire Advisory Board on Recruitment & Retention activities. As the new state legislators take office, we will also be working with them to familiarize them with the fire service and to work with them on any proposed legislation. In 2021 we will also be sponsoring a WNY Water Ball tournament and picnic as an Association activity.

We are looking to increase our membership and are actively seeking members to participate in the various committees in the Association.
